Program Planning in Process (And You Can Be Involved)

According to the LWVPA, "Program is the heart and soul of the League. It is our basis of education and advocacy." With the state convention coming up this June, it is time to review our program and positions; it is time for our local League voices to be heard at the state level. At our next LWVIC board meeting on **Monday, February 16 at 7:00 pm**, we will be discussing/participating in program planning. This is an opportunity for all of our members to be involved, and here's what you need to know.

The LWVPA holds positions under three broad programming categories—government, natural resources, and social policy. As members, we have the ability to contribute to a statewide discussion regarding these positions. In order to participate in the first step of this process, we need to make recommendations from the local level. If you would like to participate, please read as much information as you can regarding any of these positions before the board meeting. At the meeting, we will briefly discuss each position. As you read, ask yourself the following questions regarding each position:

- is it relevant, and should it be readopted in its current form?
- should it be changed or updated?
- should it be dropped or eliminated?
- is it being used at the local level and in what way?

Legislative Interview Questions 2015

1. What will you do to expand and protect the rights of ALL voters, including independents, third party voters, and citizens disenfranchised by party politics in redistricting?
2. What will you do to ensure that working women receive adequate and equitable pay?
- 3a. What will you do to clarify and strengthen regulatory oversight of transport of hazardous materials through pipelines or aging rail, truck, or barge infrastructures? What safeguards will you support with regard to storage, treatment and final disposal of these materials?
- 3b. What will you do to ensure public awareness of this issue and to protect Pennsylvania's soil and waterways?
4. What bills do you intend to introduce or co-sponsor in the upcoming session?
5. (Optional) What specific actions will you take to ensure that the Pennsylvania legislature meets its constitutional obligation to provide a thorough and efficient system of education for all?

Potluck a Learning Experience

At our January potluck meeting, LWVIC members and guests listened to a panel of local professionals discuss current developments in early education, defined as birth through age eight.

Dr. Fredelene Bowers, IUP Professor, Child Development & Family Relations; Ms. Tamara Duff, ARIN Supervisor of Early Intervention; and Ms. Janie Hess-Gray, Education Services Manager, Indiana County Head Start, presented what is known from recent brain research as well as the role of poverty in putting children at an educational disadvantage. For example, there are critical periods in brain development that peak at age four, and childhood experiences shape the structure of the brain. They discussed programs and best instructional practices currently in place in our county and elsewhere that support young children and their families. Enriched environments provided through these programs have a profound effect. Early education programs can help in identifying and providing services for children who may have special needs such as speech therapy. The success of Head Start in improving the cognitive and social abilities of preschoolers has focused attention on the importance of early childhood programs generally.

In addition, the panelists outlined the problems in implementing programs and services due to lack of funds, the difficulties in the coordination of different agencies, and the delivery of services in rural areas where children must travel great distances to access programs. Panelists responded to numerous questions from the audience, and, at the end, our group felt significantly enlightened about early education issues.
