These are the questions we will be asking the candidates.

District Attorney -

1. How do you perceive the role of District Attorney?
2. What are your goals for the district Attorney's office in the next three years?
3. Underage drinking and the sale and use of illegal drugs are a problem in our county. what are your views on incarceration versus other alternatives for convicted offenders?

County Commissioner -

1. What are the issues you consider most important for the county to address in the next three years?
2. Real estate in the county was last reassessed in 1968. What are the positive or negative factors in doing a reassessment within the next three years?
3. In light of the concerns generated when White Township supervisors agreed to timbering in White's Woods, how would you address community concerns about timbering in Pine Ridge and other county parks?

Gerrymandering and Why PA Needs Redistricting Reform

Gerrymandering: to divide (a territorial unit) into election districts to give one political party an electoral majority in a large number of districts while concentrating the voting strength of the opposition in as few districts as possible (From Merriam Webster on-line dictionary)

The League of Women Voters of PA recently testified on Capitol Hill about the need for redistricting reform in Pennsylvania. You can read LWVPA President Andrea Mulrine's full testimony online at www.palwv.org. Following is an excerpt from her statement.

The League believes that redistricting should

advance the fundamental purposes of representative democracy and government accountability by giving the people a meaningful choice in electing their representatives. Redistricting as practiced in Pennsylvania has met neither of these criteria. The process has been an insider's game. The result has been described as a "bipartisan incumbent protective gerrymander". By at least one measurement, Pennsylvania is the second most gerrymandered state in the country. Gerrymandering reduces electoral competition because legislators choose their voters rather than voters choosing their legislators. Until this last election, when voter anger over the 2005 legislative pay raise prevailed, Pennsylvania had one of the highest rates of legislative incumbent reelection in the

country. It should not take a major scandal to produce competitive elections. The League believes that the redistricting process should be assigned to an independent commission. The process must be transparent and provide a meaningful opportunity for interested parties and the public to participate effectively.
